Presentation: 3.1 Special Guest - Dr. Karen Engelsen, Vice President of Student Development

Discussion on plagiarism for continuous improvement, aligning with student learning and success. Working with student discipline noticed large number of students struggling with plagiarism, would like to mitigate in a pro-active way, convened a work group with English faculty, Writing Center, Librarians, Tutoring staff. Some ideas: include info about plagiarism on syllabus template so students see it clearly, maybe discuss at beginning of semester, English 101/Library info comp tutorial has section on plagiarism, could create a non-credit plagiarism component, support for non-English faculty with resources for plagiarism, working to get students to complete ENGL 101 in first semester/first year. Talked about having dialog in gateway courses for each RamPath, beefing up the Info Comp ILO to have more weight, concern for equity component of plagiarism, no distinction or rubric for how different levels of plagiarism are disciplined. Need for college-wide standard. Agree that it is an Academic Senate issue, this is just an introduction to the topic, request the senate consider recommendations from the work group and come forward with a final recommendation for a solution that may be implemented.

The Catalog Committee met on Tuesday, Feb. 22, 2022. We received a presentation from Jan Espinoza regarding accreditation standards that must be met within the catalog. We discussed ways to improve how easily these items can be found. We will work on entering more keywords to make the items the accrediting team might be searching for easier to find. The one item that is not in the catalog, because it does not really exist at the college, is Program Length for each degree and certificate. Debby Blanchard will explore this feature in Meta and discuss with the Curriculum Committee how this can possibly become a part of normal program updates via the curriculum process. We briefly discussed the release of Addendum #2 and Sybil Smith, Director of Financial Aid, brought us up to speed on the processes we should be following to gain approval for federal financial aid on our programs (certificates were the main concern). She will continue to work with the Office of Instruction to ensure we have a process in place moving forward. The catalog committee will be sending a survey to both VVC students and employees to measure our stakeholders' feedback on the catalog.
