Discussion, Report: 4.1 President's Report

- 1. OER Update Student at BOT meeting shared that high costs of textbooks are driving students out of college. Shared data about equity gaps, student success, need for OER, input from student voices. Dr. Wendt and Dr. Bozonelos awarded grant to write a political science OER textbook, they could share their experience to support and promote adoption of OER.
- 2. AB 927, 928, 1111 VVC must increase FTES before 2024 to avoid fiscal cliff. Growing FTES and SCFF apportionments at VVC: student success, increase opportunities, streamlining articulation. AB 928 creates single GE pathway for transfer with 34 unit limit. AB 927 expands BA degree programs in community colleges; labor market survey results show unmet workforce needs. AB 1111 calls for common community college numbering system for all GE required courses and courses in transfer pathways.
- 3. Equity in Courses not an end goal but rather the first critical step in the long road toward social justice. Four principles to get started with equity: encourage identity development; commit to equity; teach the whole person; form authentic student-teacher relationships.
