The Catalog Committee met on Tuesday, April 26, 2022. We finalized the 2022-2023 catalog cover and discussed improvements to next year's catalog based on our recent survey. We will be delaying the catalog production about two weeks due to some pending items. We will follow up with various people on campus to see if VVC should move in the direction of having a separate catalog for Noncredit.

Report: 7.4 Distance Education Advisory Committee - Michael Butros

Met last week to regroup before the end of the year, DE Coordinator Lisa Kennedy stepped down, Trish Ellerson will be retiring at end of semester, working with administration to hire another DE Coordinator position. Big question about DE Instructor Certification, will try to get it going again but do not know yet with absence of personnel, recommend that faculty and chairs let administration know about the need for on-campus certification.

Report: 7.5 Faculty Hiring Prioritization Policies and Procedures - Dr. Julia Wendt

Assembling report on final feedback for FHPC and hope to email that to ASEB and the committee by Monday. The feedback has been centering on earlier involvement from the President, more discourse between FHPC and the President during the process, and how the committee reports put findings and communicates to units not given a faculty hire. Also interest in expediting some faculty hires, as well as resource requests.

Report: 7.6 Faculty Professional Development Coordinator - Regina Pierce Brown

Wonderful event last Friday, Dr. Young was a great speaker on embedding DEI into budget augmentation process. SLOAC committee members Patty Golder, Nathan Franklin and Daniel Vecchio great presentation on assessment. Discussion on preventing classroom cheating sharing tips and techniques with other faculty. Friday, May 13, event will be Zoom only with Dr. Jamey Cooper on Humanizing Classroom & Liquid Syllabus, Brian DiBartolo on Canvas quizzes, Julia Wendt with SLO & PLO assessments. Will share list of events off-campus and will share it to faculty via email. Opportunities for faculty in volunteers to pilot Bibliu digital textbooks this summer, looking for 10 volunteers. Region 9 Rising fellowship allows students in graduate programs to shadow and learn from faculty at seven community colleges in this region, will send out notice to ask for faculty mentors, emphasis on recruiting minority underrepresented students into faculty positions, includes training for both parties and will provide stipend for both parties in fall and spring of next year.

Report: 7.7 Guided Pathways - Tim Adell, Dr. Lorena Dorn, Melanie Dube-Price

Dr. Lorena Dorn and Melanie Dube-Price attended conference last week for counselors, student engagement centers will go into place in fall, designed for all four schools, will be in the ATC, will house student success teams of faculty mentor, counselor and tutors to help students.

Report: 7.8 Honors Committee - Tim Adell

Reconstituted Honors Committee, working to add classes so students can finish 15 units. One students presented at UC Irvine conference this spring, and students are submitting articles for Building Bridges.

Preparing end of year report for shared governance committees, can be accessed by ACCJC, used as post-mortem to share accomplishments and goals for non-instructional and instructional programs.

Participated in faculty professional development presentation. Delay in migration for Nuventive but it's completed and moving format for SLO mapping, talking about best practices showcase for any department who wants to participate in the fall and tell us about student improvements. ILO assessment is waiting on copies of student writings from departments that participated in assessment and will do a meta-analysis. Ongoing discussion moving from assessing two times in three year cycle to once every three or four years for comprehensive overview of assessment.
