Reviewed slide presentation. Discussion on social justice, Academic Senate Handbook, 10+1 Academic Senate issues. Open all-call for Vice President's position. Young ascended directly to President's position due to retirement of Claude Oliver, who was scheduled to serve two year term as President. Per governing documents there is a proscribed timeline for nominations and there will need to be an election. Follow-up email will be sent out to call for nominations. Appointment of vacant area representative for Kinesiology, according to June AS meeting minutes, there were 2 votes for this position, latest vote was a tie, feel that future elections will have same results; Young in favor of appointing the position but ASEB will discuss next week. Will be sending an all-call for vacant Part Time Area Rep. APs are legally required by law, we approved 4 of the 11 needed at today's meeting, goal is to complete them by end of fall semester. Educational Master Plan update: final document should be distributed to campus and community by September 16; Superintendent President Walden would like Senate to approve it by October 1st AS meeting in order to get it to the Board of Trustees by their October meeting, concern that holding a special senate meeting to review may not give faculty adequate time to review the document. The BOT approved a resolution on social justice, Young will be developing a local senate resolution on social justice. Sent an email to faculty to update the committees membership lists.

September 17 deadline set by Office of Instruction to have the course approved for DE. Per Dean Jackie Augustine, in the next week VPI will send letter to all faculty asking how they would like to teach classes

Two sessions, 9/28-12/18, 12 week certification classes. Weekly DE Newsletter will be sent out. DE Coordinator saga continues, interviews will be held later this month. Students are emailing us to get into our classes rather than going through waitlist, critical issue for short term classes, there is a senate-approved waitlist policy, request that faculty abide by the policy, it is the equitable and fair way to do it. Concern about who determines how many positions are on a waitlist for each class.
