Changing due date for comprehensive report to December 1 in order to get data out to everybody. Young and Gibbs meeting with Institutional Research office to talk about how data is provided. Added "institutional set standards" to program review. Brown sent email to department chairs about training. Gibbs shared examples of how the data is retrieved from Power BI, issues such as how data is difficult to retrieve, reported on annual basis, difficult to read the charts, data needs to be uploaded into TracDat, concerns about navigation, faculty response and affect on productivity. Potential fixes included add URL to category of data, provide direct URL for all departments, and use data from previous reporting method.

Planning group was previously a large group, now meeting once a month on Tuesdays at 1pm, group was reformed by Dr. Newson and reduced to 18 members with only 7 faculty. Advocating for more faculty on the committee. Per Adell, need to get faculty feedback on it, we want to avoid the North Carolina model that was used to eliminate programs, it's possible it could end badly, important to take it seriously.

VVC was awarded HSI grant, think it is \$500,000 for next 6 years, looking at increasing OER use. Continuing to advocate for OER adoption across the board, and make sure our classes with OER are being published online in WebAdvisor, being told it's not being done due to some issues with bookstore, instruction office and IT.
