3. Discussion Items

3.1 AP 1201 Participatory Governance Structure & Responsibilities –

Per Bennett, AP 1201 originated from College Council and will be third reading at next meeting in January. Senate's role is defined by BP 2510, based on AB 1725. APs related to 10+1 issues are originated in senate and after approval go directly to Superintendent/President, Curriculum Committee actions go directly to BOT. Per Oliver, College Council voted on two revisions to the document: keeping "senior staff" as voting members on College Council; composition of participatory governance committees to be limited to 4 members, with administrator and faculty cochairing committee along with a classified and student member. Discussion: two shared governance committees are included in VVCFA contract. Ed Code 53203 has wording regarding membership being made through consultation rather than appointment and union representation on college-wide committees. Concern about impact and influence of votes/perspectives by senior staff and vicepresidents on their subordinates. Historically, a prior version of AP 1201 originated from a faculty task force initiated by Peter Allan when he was interim president. Originally College Council was not a voting body but rather a means for sharing information. Superintendent/President may make changes or decline to approve this document. Senate will open the issue of "senior staff" back up at next College Council meeting. Requesting feedback from faculty who serve on shared governance committees on what they feel about the proposed 4-member committee composition. Concerns include: lack of representation of part-time faculty on shared governance committees; limited knowledge and viewpoints; inability of faculty to meet 18-hours of contractually required professional obligations; concern about having a single faculty member on the committee and the workload required to co-chair a committee; potential for faculty grievance if recommended faculty member is not appointed because it will limit the faculty member from meeting contractual obligation; concern that we already eliminated senior staff because it took away our voice and we are going backward in the process. Bennett would appreciate voice of union representatives at the College Council meetings.

Registration problem caused by repeatability restrictions. Process is used at other colleges. Concern about students having access to all course materials and then repeating course. Stahlke to review current administrative procedures, come up with process and form and bring back to Senate.
