GOVERNOR'S BUDGET PROPOSAL FOR FY 2019-20

The Governor's January budget proposal is the annual kickoff to the legislative process that eventually culminates with the enacted budget adopted in June. In between, the legislature and the Governor jostle to various extents on policy and programs. Over his two terms, Governor Jerry Brown's vision typically prevailed over the legislature; as this is the first budget proposal for newly elected Governor Gavin Newsom, the level of deference the legislature will give him is uncertain.

The proposed state budget is strong, with increasing general fund revenues and a continued commitment to pay down liabilities and save for future economic uncertainties. To that end, the Governor proposes one-time payments to CalPERS and CalSTRS to buy down its share of the liability as well as an additional \$1.8 billion transfer into the state's Rainy Day Fund. Enacted in FY 2014-15, the Rainy Day fund is estimated to have \$15.3 billion in FY 2019-20 putting it at the constitutional limit of 10 percent.

Of importance to the community college system, the Proposition 98 system guarantee has increased, which provides additional funding for system priorities. While some of this increase is offset through recalculations of the two prior fiscal years, it is certainly positive news for the community college system and the District. Notable ongoing funding and other proposals within the Governor's budget, with the impact on the community college system and the District, are bulleted below:

- \$248.3 million to fund a 3.46 percent cost of living adjustment (COLA).
 - o <u>District Impact</u>: Based on the District's 2018-19 SCFF funding of \$65,178,000, the impact of 3.46% COLA is \$2,255,000.
- \$40.0 million to expand the College Promise to include the second year costs of attendance for first time, full-time student.
 - o District Impact: None
- Relief on increases to CalSTRS employer-paid pension costs.
 - o <u>District Impact</u>: The Governor is proposing a large one-time payment to CalSTRS that would reduce the mandated increase from 18.13 percent to 17.10 percent. Currently the District pays 16.28 percent. This would reduce the District's payment by approximately \$270,000 in FY 2019-20, although the increase would still be approximately \$215,000.
- A one-year freeze on the SCFF funding formula shift from the Base Allocation to the Student Success Allocation.
 - District Impact: The fiscal Impact in FY2019-20 of this proposed change is \$772,000. It is notable that the new Governor has indicated a willingness to pause, at least for a year, the planned two-year transition of lowering the Base Allocation from 70 to 60 percent and elevating the Student Success Allocation from 10 to 20 percent.

18.06 percent to 20.80 percent, a \$269,000 year-over-year expenditure increase. These employer-paid pension obligations will continue to grow substantially through FY 2020-21.

Bulleted below are the next steps in the budgetary process.

- Legislative Analyst's Office will review the Governor's proposal in February.
- Legislature reviews the proposal March through May.
- In May the Governor will issue his "May Revision" with updated revenue forecasts and more detailed proposals.
- Official budget enacted by June 30, 2019.

FY 2018-19 Budget Update

- On target with our budget; revenues and expenditures are coming in as expected.
- In February, the FY 2017-18 apportionment recalculation will occur and any needed adjustments will be made, although nothing substantive is expected.

Dear President Henderson,

As Vice President of the Board of Trustees for Victor Valley Community College, I would greatly appreciate it if you would work with Dr. Daniel Walden, our new President and Superintendent, for some following items I would like to see on the March 2019 agenda and agendize as follows:

1. Student Housing: Over the past many years, many of our student athletes have not been able to find adequate housing. The question is how many other students could we encourage to attend Victor Valley Community College (from outside the area) whether for athletics or for educational purposes that would benefit from an independently owned and run student housing complex?

At the CCLC November 2018 Conference, there was a discussion about the potential need for student housing, companies that are in that business and the cost to do a preliminary feasibility study to determine if there is a need (basically a supply and demand analysis). I would ask our fellow trustees to strongly encourage Dr. Daniel Walden to discuss this need and the companies that could potentially be interviewed through a request for qualifications (RFQ) as well as a request for proposal (RFP) sometime in the upcoming months.

The Community College League undoubtedly knows that there is an issue and I am sure they have all the names of the companies that do the proposed feasibility studies as well as the names of the developers that would be willing to submit their qualifications and proposals.

2. Request that Mr. Steve Garcia our Director of Facilities, give a report to the Board of Trustees on the proposed conference center that was discussed originally nearly two years ago. At the same time, there was a discussion about realigning and repositioning the football stadium with more permanent bleachers and upgrading the facility to upgrade our football program.

I strongly believe that a conference center would be a great asset to the High Desert community and to the Cities of Adelanto, Apple Valley, Hesperia and Victorville. I would suggest that it would seat at least 500 people, have a kitchen for events and also a place to hold our Board of Trustee meetings with adequate and comfortable seating for our residents, students and faculty, etc.

3. I know before I became a Trustee that there had been discussions about serving beer and wine at certain events on the campus and there was a lack of support. I would appreciate it if the Board of Trustees would request Dr. Walden to have a discussion with the Victor Valley Community College Foundation and the Victor Valley Community College Associated Student Body (VVCASB) to determine whether there are opportunities for the Foundation or the ASB to serve beer and wine at events that benefit the Foundation and/or ASB (by making money) and also benefit those that wish to attend and those that would possibly not attend without it.

I recently attended a function at Yavapai Community College (in Prescott Arizona) a community college. Not only do they serve beer and wine at their events at their Performing Arts Center, they also serve hard alcohol and they have found it very profitable but are cautious about how they serve it to college students as well as to adults. Arizona has a very tough drinking and driving law.

I thank you in advance for placing these items on the March 2019 Agenda.
