2. SUPERINTENDENT/PRESIDENT'S REPORT

2.1 Citizens' Bond Oversight Committee Annual Report

Bond Oversight Committee Chair, Richard Greenwood presented the Bond Measure JJ annual report. He reported that the audit showed that bond funds have been spent properly, then asked for questions from the Board.

2.2 FOUNDATION

Foundation President Mike Nutter was presented with a \$25,000 check from Southern California Edison's government relations officer, Juan Lopez for the Project Spark Program, which awards funding for the fire technology program's present and future fire personnel. Only five colleges have received this grant. Mr. Lopez thanked the Board for their service to the students. Mr. Nutter also reported on the Alumni Hall of Fame event. Net proceeds for the event totaled \$146,502. He continued his report sharing that the deadline for scholarships has been extended by one week, to March 22 with an additional two weeks to submit letters. Also, campus grants for spring are due this Friday, March 15 and will be awarded on or before April 15. Thank you cards from students were passed around for the Trustees to see.

Academic Senate President Lee Bennett reported out on the temperature of VVC faculty, stating that there is a level of excitement and engagement with campus activities and all they are doing. Faculty will be engaged in Guided Pathways, giving them good direction on how VVC will move forward as a campus. It will be transformational for student success. Trustee Brady requested that Mr. Bennett bring back faculty members to present to the Board about the exciting things they are doing.
