# RESOLUTION NO. 10-10 RESOLUTION OF THE BOARD OF TRUSTEES OF VICTOR VALLEY COMMUNITY COLLEGE DISTRICT DECLARATION OF EMERGENCY CONDITION

WHEREAS, the Public Contract Code Section 20113 relieves the governing boards of school districts from bidding requirements when, in an emergency, any repairs, alterations, work or improvement is necessary to permit the continuance of existing classes or to avoid danger to life or property; and

**WHEREAS**, on August 5, 2010, it was discovered that a leak in the hose bib on the northwest exterior corner of the gym caused damage to the gym floor; and

**WHEREAS,** repairs, alterations, work improvement is necessary to permit the continuance of existing classes, sports, and to mitigate a potential tripping hazard; and

**WHEREAS,** the cost to make such repairs will exceed the statutory limit for bidding requirements; and

WHEREAS, the District has insufficient time to advertise for bids;

**THEREFORE BE IT RESOLVED,** that the Governing Board of the Victor Valley Community College District declares that an emergency condition exists.

IT IS FURTHER RESOLVED, that the Administration of Victor Valley Community College District is authorized to request relief from the bidding requirements from the San Bernardino County Superintendent of Schools.

IT IS FURTHER RESOLVED, that Christopher C. O'Hearn, Interim Superintendent / President is authorized to sign all related documents.

This resolution is hereby adopted, authorizing the Declaration of an Emergency Condition.
