3. OPEN SESSION REGULAR MEETING

6 p.m.

3.1 At 6:22 p.m. Board President Range reconvened the meeting. Mr. Jeffery Morris, legal representative with Stutz, Artiano, Schinoff & Holtz, announced that as a result of Closed Session the following occurred:

4. SUPERINTENDENT/PRESIDENT'S REPORT

Mr. Range announced that the video streaming will be discussed by the Board of Trustees at the end of the Superintendent/President's report.

Dr. O'Hearn reported that classes started today at the Regional Public Safety Training Center and encouraged everyone to visit the complex.

Vice President Javaheripour was pleased to report that as a result of the energy management project that was implemented last spring, representatives from Southern California Edison were presenting the District with an energy efficiency incentive check in the amount of \$233,227.

Lorena Ochoa, Counselor and Dean Tim Johnston spoke on the various services the Transfer Center provided to the students.

Dr. O'Hearn reported that a draft of PPL's accreditation report was received today and the Administration was pleased with what is being presented.

Trustee Brady gave a report on a CCLC Trustee Workshop that he attended with Trustee Range in late January. A copy of the report is available for review in the Superintendent/President's office.

Academic Senate: On behalf of the Academic Senate, Lisa Harvey reported that three potential faculty members have been successfully interviewed and those members have been extended positions. The Biology Department will be submitting a multi-million dollar five-year grant through the National Science Foundation which will include Biology, Chemistry and Psychology departments which will help us provide students research opportunities and monies to participate in the research. In an effort to address the campus climate, Zombies will be coming to Victor Valley College which will be referred to Humans vs. Zombies. This is a weeklong game in which the students, faculty, staff and hopefully administration will want to participate.

Following Dr. O'Hearn's report, President Range spoke on the policy of web streaming. He feels the District has not notified or posted in the room that individuals are being videotaped. He wanted to use this meeting to provide the Board members an opportunity to speak their issues about this subject. He feels that some type of process or procedure should be created to address web streaming. He apologized for any miscommunication that has occurred and assumes all responsibility and hopes to have it all resolved by the March 13th Board meeting. Trustee Brady was concerned that Granicus had failed us and hoped to see this resolved quickly. Trustee Denson agreed with President Range that it does need to be posted and that it should be implemented as soon as possible. Trustee Henderson is concerned regarding the legal aspect of video streaming and felt that it should be posted that the meeting is being recorded. Jeff Morris, legal counsel, proposed that the current board policy (BP 2365) should be updated to reflect the live web streaming and present that at the March meeting for a first reading for discussion. Trustee Krause would like to see the protocols in for the next meeting. He pointed out that the board meeting had started to be recorded and it was cut off this evening and that he was unaware of that decision and takes no responsibility for that action. It was pointed out by Jeff Morris that an audio recording was still in effect with the recording available in the Library as well as the President's Office. President Range pointed out that this was the first opportunity to discuss this topic amongst all Board members. He would like the quality of the video improved, the camera position needs to be relocated, the agenda should be on a screen to allow the audience to follow the meeting, voting lights and monitors should be a part of the upgrade.
