# 4. Superintendent/President's Report:

Board President Denson introduced Evelyn Blanco, Student Trustee.

Peter Allan read aloud a statement regarding item 12.0 explaining the need for the MOU.

Mr. Allan Introduced James Johnston and Sierra Orr with the VVC Foundation. They provided background information on the Small Business Grant recently received and the benefits it will provide Victor Valley College. Mr. Allan thanked the Foundation in securing the grant, which is the largest one received thus far.

Mr. Javaheripour reported on the budget workshop he recently attended at Mt. Sac. An extended budget workshop is planned for the September Board meeting. Board President Denson asked that a presentation on the FCMAT report will be included in the workshop.

New VVC employees Karen Hardy, Marcus Jackson, Peter Maphumulo, Amy Norris, Hector Bastillos, Renny Thoms and Sergio Oklander were introduced and welcomed.

Academic Senate: Tracy Davis welcomed new Student Trustee, Evelyn Blanco. Ms. David spoke on the correspondence that was delivered to ACCJC President Barbara Beno, regarding the complaint made against ACCJC by several groups and individuals from City College of San Francisco. The Senate feels that Board Policy 2110 regarding the replacement of a Trustee has not been followed in its entirety. The provisions of BP 2110 call for either a provisional appointment, or a special election, which would elect an interim Trustee until the next regularly scheduled election, which would be November 2014.

Jeff Morris, legal counsel explained that a special meting has been noticed to continue the discussion of making a provisional appointment. The Board of Trustees met on August 8<sup>th</sup> to answer two questions, either to call for a special election or to make a provisional appointment. The Board of Trustees attempted to implement Board Policy 2110 which would have been started at the July 9 and July 18 meetings. At both meetings the Board of Trustees were unable to make a decision. A notice was provided well in advance explaining the purpose of the special meeting as well as allowing sufficient time for the public, Board of Trustees, constituency groups to attend the meeting. The Board is now down to 15 days to make a provisional appointment. If they are unable to make a provisional appointment the District will be facing, by default, a special election.
