- 4. SUPERINTENDENT/PRESIDENT'S REPORT

BOARD OF TRUSTEES: Joseph W. Brady, Lorrie Denson, Dennis Henderson, Michael Krause, Joe Range, and Student Trustee

Tom Turner spoke on the 9-11 events that occurred this week on campus which included a moment of silence and placing a wreath at the bell.

Fusako Yokotobi spoke on the ACCA leadership training attended by Dino Bozonelos, Dr. Joseph Morris and Kimberly Day.

Professor Steve Toner thanked everyone that was involved in establishing a math support center located in the Academic Commons and is looking forward to supporting the goal of student success.

5.8 <u>Independent Contractor Agreement – Johnny Ramirez</u>

Approval of the agreement between Victor Valley Community College District and Johnny Ramirez to provide academic workshops/training to GEAR UP students and parents. The service period for this agreement is September 12, 2012 through December 20, 2012. Fiscal Impact: \$10,000.00, GEAR UP grant funded.

5.9 PULLED FOR SEPARATE DISCUSSION (see Agenda Item 6.1)

Agreement Renewal - ACT, Inc.

Ratification of the Agreement between Victor Valley Community College District and ACT, Inc. to provide a comprehensive, computer-adaptive testing program that assesses students' skill levels in mathematics provides placement information and connects students to the campus resources they need to achieve their academic goals. The period of this agreement is from July 20, 2012 through August 31, 2012 and will automatically be renewed for successive one-year periods for a total contract period not to exceed five (5) years. Fiscal Impact: \$12,348.00, budgeted item.

5.10 Independent Contractor Agreement - Patricia Pena

Ratification of the agreement between Victor Valley Community College District and Samuel Sepuya, M.D. to serve as the Medical Director for the District's Respiratory Therapy Program for the 2012-2013 school year. The period of this agreement is from August 27, 2012 to August 26, 2013. Fiscal Impact: \$4,000.00, budgeted item.

Ratification of the agreement between Victor Valley Community College District and Hesperia Unified School District to lease six (6) classroom spaces at Hesperia High School to hold college courses at this site. Fiscal Impact: \$15,300.00, budgeted item.

5.18 Agreement Renewal - Victor Valley Unified School District

Ratification of the agreement between Victor Valley Community College District and Victor Valley Unified School District to lease eight (8) classroom spaces at Victor Valley Unified School District to hold college courses at this site. Fiscal Impact: \$20,400.00 budgeted item.

5.19 Agreement - Merrell Johnson Companies

Approval of the agreement between Victor Valley Community College District and Merrell Johnson Companies for soils surveys and engineering as required by the Division of State Architect's office (DSA) to complete the foundation work for the installation of Solar Car Port structure Photovoltaic systems in parking lots 11, 12 and 16. Ratification of the agreement between Victor Valley Community College District and Southern California Edison for a company release allowing SCE to complete a case study of the District's 1 Megawatt Solar Facility. Fiscal Impact: None.

5.22 Agreement Renewal - Solarwinds, Corp.

Ratification of the agreement between Victor Valley Community College District and Solarwinds, Corp. for its software suite that allows network managers to monitor many servers and other devices for outages on and off campus. Term 9/18/12-9/17/13. Fiscal Impact: \$4,489.00, budgeted item.

Ratification of the agreement between Victor Valley Community College District and Bomgar Corporation for software to assist the help desk and other technical personnel to view and control any workstation on or off campus with troubleshooting when students or staff call with technical computer problems. The period of this agreement is from October 1, 2012 through September 30, 2013. Fiscal Impact: \$2,753.60, budgeted item.

5.25 Correction to Contract Amount - Somerset Capital Group, Ltd.

Ratification of the agreement between Victor Valley Community College District and Somerset Capital Group, Ltd. to correct the Board item submitted and approved at the August 14, 2012 Board of Trustees meeting to include the omitted sales tax. (Item #IN-43, on Campus Technology Project list) Fiscal Impact: \$1,112.13, budgeted item.

5.26 Agreement Renewal - Industry Weapon, Inc.

Ratification of the Agreement between Victor Valley Community College District and Industry Weapon, Inc. for Command Center HD (CCHD) licenses used to power the digital signage located at the Regional Public Safety Training Center. Term: 9/2/12-9/1/13. Fiscal Impact: \$2,250.00, budgeted item.
