3. OPEN SESSION

3.1 Closed Session Report: Board President Denson reconvened the meeting at 6:25 p.m. and reported that was not action as a result of Closed Session.

4. Superintendent/President's Report:

Superintendent/President Peter Allan introduced Richard Petterson with the Town of Apple who made a presentation on the anticipated bike path.

Ginger Ontiveros introduced Tony Bonato who presented on the VVC Construction Technology programs, with an emphasis on the solar technology program.

Excelsior High School student Charity Lindsey provided her testimony from her experiences attending simultaneously attending VVC and Excelsior High School. This year she will be graduating from both VVC and Excelsior.

Academic Senate: Tracy Davis thanked administration for their efficient scheduling of the ACCJC site visit last Monday, November 4, 2013. In addition, the Senate also thanked Trustee Pinkerton for his presence at the early morning session to welcome the visiting team. She pointed out that two members of the visiting team recognized all the hard work faculty had completed regarding recommendations 2 and 3. In response to an agenda item regarding the proposed revision of BP#2210, the Senate feels that the current practice is fair, and provides observational training for new Trustees, so when their turn arrives, they can draw on the wealth of information and knowledge of previous Board of Trustee presidents. Finally, the Senate welcomed the notice that VVC is beginning the process of hiring a permanent Superintendent/President and pointed out that Peter Allan has provided excellent leadership this semester. It is imperative that VVC focuses on the next academic year, and that we have a president who is permanent and will guide us into the future. The Senate thanked the administration and Board of Trustees in advance for the customary inclusion of the search.

5.2 <u>Notice of Completion – Cooley Construction</u>

Ratification of the Notice of Completion with Cooley Construction for the drainage channel repair project. This agreement was originally Board approved on August 13, 2013. Fiscal Impact: None

5.3 Agreement - Merrell Johnson Companies

Ratification of the agreement between Victor Valley Community College District and Merrell Johnson Companies to use the three (3) year agreement, that was originally approved by the Board on April 9, 2013, to assist with the Stormwater Multiple Application and Report Tracking Systems (SMARTS) process pertaining to the Health/Science Building project. Fiscal Impact: \$13,800.00, bond funded.

5.4 <u>Agreement – Merrell Johnson Companies</u>

Ratification of the agreement between Victor Valley Community College District and Merrell Johnson Companies to use the three (3) year agreement, which was originally approved by the Board on April 9, 2013, for materials testing and special inspection services needed during the drainage channel repair project. Fiscal Impact: \$12,262.50, Fund 71.

5.5 Site Ground Lease Agreement – Excelsior Education Center

Ratification of the agreement between Victor Valley Community College District and Excelsior Education Center for school purposes as authorized by the Charter Agreement between Victor Valley Union High School District and Excelsior Education Center. Excelsior currently leases 3.64 acres from the District. Fiscal Impact: \$3,264.00, monthly, \$39,168.00 annually, to increase by 3% annually, **Revenue to the District.**

5.6 Agreement – A&E Inspection Services

Ratification of the agreement between Victor Valley Community College District and A&E Inspection Services to use the existing three (3) year agreement that was originally approved by the Board on April 12, 2011, to provide Inspector of Record services needed during the drainage channel repair project. Fiscal Impact: Not to exceed \$2,000.00, Fund 71.

5.8 <u>Agreement Renewal – Datawatch</u>

Ratification of the renewal agreement between Victor Valley Community College District and Datawatch for one year to continue maintenance support for Monarch software. This product provides the capability to extract, analyze and export data from existing reports without programming. Monarch also lets users combine and import data from additional data sources, such as databases or spreadsheets. Term: 11/2/13-11/1/14. Fiscal Impact: \$3,879.20, budgeted item.

5.9 Agreement – Dell, Inc.

Ratification of the renewal agreement between Victor Valley Community College District and Dell, Inc. for the purchase of 10 hours of remote professional services for the configuration of SQL in regards to KACE. (Item #IN-62, on the Campus Technology Project list). Fiscal Impact: Not to exceed \$2,500.00, budgeted item.

5.10 Agreement Renewal - Visual Click Software, Inc.

Ratification of the renewal agreement between Victor Valley Community College District and Visual Click Software, Inc. for licensing that will allow us to monitor servers at Victor Valley College, this includes support and maintenance. Term: 10/1/13-6/2/14. Fiscal Impact: \$1,906.67, budgeted item.

This increase will be effective with the Winter 2014 semester. Fiscal Impact: None.

Ratification of the agreement between Victor Valley Community College District and Beckman Coulter for the servicing of equipment used in the Biology Department. The period of this agreement is November 15, 2013 through November 14, 2014. Fiscal Impact: \$1,719.73, budgeted item.

Ratification of the Child Development Training Consortium agreement between Victor Valley Community College District and Yosemite Community College District. The grant program benefits students who are currently employed in early childhood setting, encouraging them to return to school to further their education and increase their skill by assisting them in their tuition and textbook expenses. The term of this agreement is September 1, 2013 through June 30, 2014. Fiscal Impact: \$9,375.00 Income to the District.

5.21 <u>Agreement – California Early Childhood Mentor Program – Chabot-Las Positas Community College District</u>

Ratification of the agreement between Victor Valley Community College District and Chabot-Las Positas Community College District, on behalf of its California Early Childhood Mentor Program for the 2012-2013 academic year. Through this contract mentors are selected from a variety of early childhood programs in the high desert. The students will be placed in these programs for the lab hours necessary for completion of CHDV 210. The period of this agreement is from August 1, 2013 through July 31, 2014. Fiscal Impact: None

5.22 <u>Library Online Database Subscriptions</u>

Approval of the renewal of online database subscriptions through the Community College Library Consortium for the period of January 1, 2014 through December 31, 2014. Fiscal Impact: \$13,216.00, budgeted item.
