

CALIFORNIA BAPTIST UNIVERSITY TRANSFER ADMISSION GUARANTEE

This document details the Transfer Admission Guarantee (TAG) agreement between California Baptist University (CBU) and Victor Valley College. The agreement is designed to assist and facilitate the transfer process to CBU. Students can receive early review of their academic record, admission notification, and specific guidance on major preparation and general education coursework.

If you are interested in a TAG, your next step is to meet with your community college transfer counselor. The transfer counselor will work with you to complete a transfer agreement before sending it to us. Once approved, you will continue the transfer process by completing the formal CBU application process and forwarding official transcripts.

TAG Guidelines

Policy guidelines for this Agreement are as follows:

- A) To obtain eligibility, the prospective student must complete a minimum of 12 transferable semester units with a minimum cumulative GPA of 2.0 from all schools previously attended. Official transcripts from all previous colleges attended must be submitted with the application to verify GPA eligibility.
- B) All TAG students must select a baccalaureate-level academic program which is part of the official Articulation Agreement between CBU and Victor Valley College in effect for the catalog year in which the TAG student has been approved.
- C) Completion of IGETC or CSU General Education Breadth <u>and</u> an associate's degree will permit a student to be waived from all general education requirements with the exception of English 113 (Composition), English 123 (Intermediate Composition), and the Christian Studies requirement. <u>All</u> areas of the IGETC or CSU General Education Breadth must be completed prior to transfer. Additionally, all pre-requisite coursework for specific majors must be completed prior to beginning any major coursework.
- D) A maximum of 70 units is allowable for transfer from community colleges. Coursework completed at the lower division level is not eligible for upper division credit. Additionally, only coursework of <u>C</u>- or better is eligible for transfer.
- E) A maximum of 30 semester units is allowed for transfer from examinations (CLEP, AP, Dantes and IBO). An overall maximum of 100 semester units, including military service may be accepted in transfer toward fulfilling degree requirements.
- F) Student understands that he/she is eligible to transfer to CBU from Victor Valley College under this TAG agreement anytime up to one year after their last term of attendance at Victor Valley College and up to a maximum of three years after signing the TAG agreement.
